NEONATAL / PEDIATRIC CHEST TUBE PLACEMENT (Neonatal, Pediatric) 4 2. Locate The Site For Insertion.

In Case Of Pleural Fluid Collection, If Feasible, Use Ultrasonography To Locate The Optimal Site For Chest Tube Placement. In Pediatric Patients This Should Usually Be The Fourth Or Fifth Intercostal Space In The Mid-to-anterior Axillary Line. Jan 10th, 2024
