Measure #1: Tax On Split Income (“TOSI”) To Address Income ...

Subject To The TOSI Rules, They Will Incur Tax At The Highest Marginal Personal Tax Rate Without Any Personal Tax Credits (i.e. Do Not Get The First \$11k Or \$18k That Does Not Incur Any Tax).
